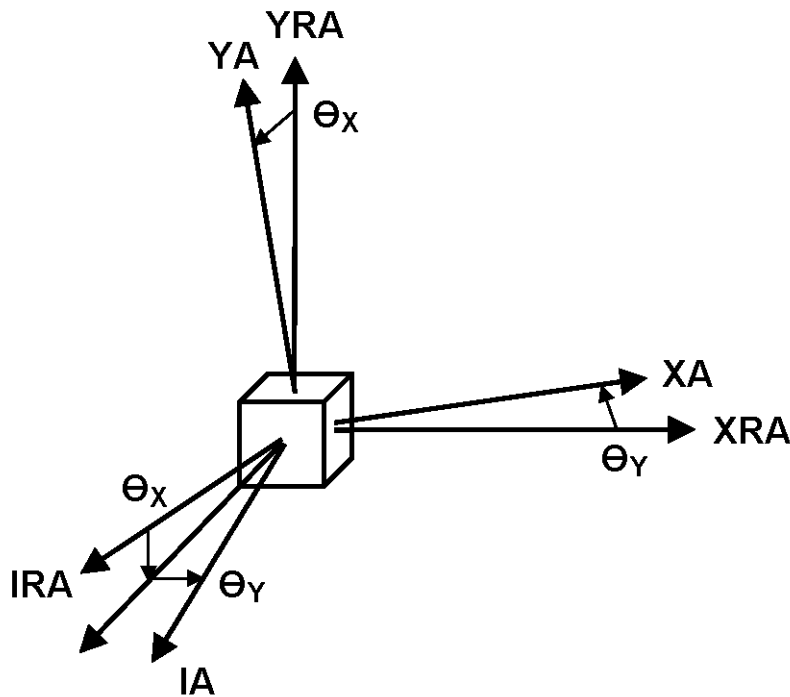


Figure 1—Gyro axes and misalignment angles
